Earth Day 2022 Green Initiative



Once again, mc² celebrated Earth Day 2022, themed "Invest In Our Planet," with our annual green initiative. On Friday, April 22, we retired Midwest-based, wind-generated Renewable Energy Certificates (RECs) equal to 100% of the amount of energy that our entire client base consumed that day. Our client base includes all residential, commercial, educational, and governmental mc² customers in Illinois and Ohio, states in which we are a certified retail electric supplier. The RECs that we retired are in addition to existing state-mandated Renewable Portfolio Standard (RPS) requirements. The amount is equivalent to eliminating more than 3,000 metric tons of CO² from the atmosphere. mc² continuously looks for ways to support the development of renewable generation resources in the Midwest to help build a sustainable future for everyone.

As of April 2022, the electric supply price to compare to is currently 7.809 cents per kWh ¹. The electric utility electric supply price will expire on May 2022. The utility electric supply price to compare does not include the purchased electricity adjustment factor. The purchased electricity adjustment factor may range between +.5 cents and -.5 cents per kilowatt-hour. Electric supply price to compare for other rate classes (in cents per kWh) that are currently applicable include: Watt-Hour Non-Electric Space Heating - 7.844 cents/kWh; Demand Non-Electric Space Heating - 7.875 cents/kWh; Nonresidential Electric Space Heating - 7.539 cents/kWh; Dusk to Dawn Lighting - 4.024 cents/kWh; General Lighting - 7.243 cents/kWh.

Illinois Required Disclosure (Ameren Service Area)

MC Squared Energy Services, LLC (mc²) is not the same entity as your electric delivery company. You are not required to enroll with mc². As of April 2022, the electric supply price to compare to is currently 5.478 cents/kWh (Up to 800 kWh) and 5.280 cents/kWh (Above 800 kWh)¹. The electric utility electric supply price will expire on
